WHEREAS, by Local Law No. 4-2004, dated December 7, 2004, the Board of Trustees established the Personal Wireless Services Facilities Board (“PWSF”) to review PWSF applications for Special Use Permits; and

WHEREAS, pursuant thereto, Dish Wireless L.L.C., paid a \$5,000.00 filing fee and filed an application with the PWSF to install wireless equipment at the 56 Elm Avenue known as Section 34, Block 386, Lot(s) 145,146, 236-244, 247-252) on the Land and Tax Map of the County of Nassau; and

WHEREAS, on May 26, 2022, the PWSF Board held a public hearing on the application of, Dish Wireless L.L.C. to install said wireless equipment; and

WHEREAS, by a Decision, identified as “Case 95,” (attached), the PWSF Board granted the aforementioned application and, accordingly, the Zoning Officer caused to be issued a “Special Use Permit”, Dish Wireless L.L.C., Inc. for the said site; and

WHEREAS, said application approval and Special Use Permit were made conditional upon the approval of said application and a Site Licensing Agreement between the Village and Dish Wireless L.L.C.; and

WHEREAS, the said Site License Agreement provides for an initial term of sixty (60) months/(five (5) year) from the Commencement Date (i.e. the date of the issuance of the Building Permit), which may be extended for four (4) additional 60 month (five (5) year) terms. Pursuant thereto, Dish Wireless L.L.C. will pay to the Village rent in an amount of \$2400.00 monthly, plus a three a (3%) percent annual rent increase, with payments delivered to the address provided in said lease or by electronic payment; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Incorporated Village of Hempstead, hereby ratifies and approves the actions of the PWSF Board in granting the application Dish Wireless L.L.C. to install wireless equipment at 56 Elm Avenue known as Section 34, Block 386, Lot(s) 145,146, 236-244, 247-252) on the Land and Tax Map of the County of Nassau; and

BE IT FURTHER RESOLVED that the Board of Trustees of the Incorporated Village of Hempstead hereby approves the aforementioned Site License Agreement with Dish Wireless L.L.C.; and

**CHAPTER 4 "CITY CHARTER
COMMISSION"**

Clerks offers the following resolution for adoption:

WHEREAS The Village Board of Trustees desires to amend the Code of the Incorporated Village of Hempstead so as to establish a city charter commission to assist and advise the Board of Trustees to advance the Village of Hempstead becoming a city;

WHEREAS, pursuant to § 617.5 (c) 21 and 33 of SEQRA, regulations amending the Code of the Incorporated Village of Hempstead are "routine or continuing agency administration and management, not including new programs or major reordering of priorities" and "promulgation of the regulations, policies, procedures and legislative decisions in connection with any type II action," and therefore, this proposed action, a Type II action, requires no further action pursuant to SEQRA.

**NOW, THEREFORE THE VILLAGE BOARD
OF TRUSTEES**

HEREBY SCHEDULES a public hearing to be held on the 3rd day of **August 2022** at **6:15 p.m.** at the Hempstead Village Hall, 99 James A. Garner Way, Hempstead, New York, to consider adding

Chapter 4 "City Charter Commission" to the Hempstead Village Code as follows:

SECTION 4-1: Establishment of Commission.

A. A City Charter Commission is hereby established by the Village.

B. The City Charter Commission, shall consist of not more than fifteen 15 members, including the Mayor and Trustees. All non-elected members shall be appointed by the Mayor of the Village of Hempstead and shall be Village residents with demonstrated interest and commitment to serve and reflect the diversity of the community. Such non-elected members shall serve at the pleasure of the Board of Trustees.

SECTION 4-2: Purpose and Intent

The purpose and intent of this local law is to establish an advisory City Charter Commission to assist and advise the Board of Trustees to advance Hempstead becoming a city.

SECTION 4-3 Powers and Duties of Commission

The City Charter Commission is charged with developing a draft city charter that would form the basis for special legislation that would be advanced in the State Legislature. The Commission shall exercise such other powers and duties as the Board of Trustees may so direct to advance the objective of city status. The City Charter Commission shall be advisory only to the Board of Trustees.

SECTION 4-4. Administration of Commission.

The City Charter Commission shall elect the Chair at its first meeting. The Commission shall meet regularly and at the call of the Chair for a special meeting, should the need arise. Meetings shall be conducted, and minutes taken in accordance with the Open Meetings Law.

SECTION 4-5 Community Engagement.

The City Charter Commission shall, to the greatest extent practicable, solicit public comment and engage the community. To that end, the Commission may facilitate community engagement in the form of a neighborhood meetings, public forums, mailing or surveys.

SECTION 4-6 Outside Resources.

It is recognized that outside resources will likely be necessary for the City Charter Commission to discharge its important duties. In the exercise of its due diligence, the Commission shall identify the need for outside resources, solicit same in accordance with applicable law and/or the Village's procurement policies and, upon selection of same, make request to the Board of Trustees for retainer and an appropriation to cover any expense.

SECTION 4-7 Report to the Board of Trustees.

The City Charter Commission shall establish a work schedule, set milestones, and provide timelines for deliverables. The Commission shall further make periodic report to the Board of Trustees as to its progress. It is expected that the Commission will endeavor to complete its work which shall consist of a final report and draft city charter, with all deliberate speed so that the Board of Trustees may consider same for timely action by the State Legislature.

SECTION 4-8 Compensation

Each member of the Commission shall serve without compensation

SECTION 4-9 Supersession

This local law shall supersede any inconsistent or conflicting provisions of the Village Code or Charter
