ONCE YOU HAVE ACQUIRED THOSE CARDS PLEASE GO TO OUR **POLICE HEADQUARTERS** WHICH IS LOCATED AT **1490 FRANKLIN AVENUE IN MINEOLA, NY 11501** – THEY ARE OPEN FOR FINGERPRINT PROCESSING **MONDAY-THURSDAY 9-4**. THIS PRECINCT WILL CHARGE A PROCESSING FEE OF MAX \$50.00 (CREDIT, DEBIT OR MONEY-ORDER; NO CASH), WHICH IS SUBJECT TO CHANGE.

AFTER COMPLETION OF THE ABOVE, PLEASE BRING WITH YOU THE FOLLOWING:

- FINGERPRINT RESULTS (FROM MINEOLA - EITHER A **LETTER OF GOOD CONDUCT** OR **HISTORY OF INFRACTIONS**).
- APPLICATION FORM (PLEASE PRINT CLEARLY) – **MUST BE NOTARIZED**
- YOUR **CLASS "E"** NEW YORK STATE DRIVER'S LICENSE
- TWO (2) **PASSPORT** SIZED PHOTOS
- **\$90.00 CASH, MONEY ORDER OR CREDIT/DEBIT CARD (NO PERSONAL CHECKS)** FOR TAXI DRIVER APPLICATION FEE (PLEASE MAKE MONEY-ORDER PAYABLE TO: **INC. VILLAGE OF HEMPSTEAD, 99 JAMES A. GARNER WAY, HEMPSTEAD NY 11550**)

IF YOU HAVE BEEN CONVICTED OF ONE (1) OR MORE VIOLENT FELONIES AT ANY TIME PREVIOUSLY, OR CONVICTED WITHIN THE LAST FIVE (5) YEARS OF MORE THAN ONE (1) VIOLENT FELONY AND ONE (1) OR MORE MISDEMEANORS, OR TWO (2) OR MISDEMEANORS, YOU MAY NOT BE ELIGIBLE.
