GARAGE SALE RULES AND REGULATIONS

1. APPLICATION MUST BE FILED WITH THE VILLAGE CLERK'S OFFICE.
2. AN APPLICATION FEE OF \$15.00 MUST BE PAID AND IS NOT REFUNDABLE
3. A LICENSE SHALL BE ISSUED FOR NOT MORE THAN TWO (2) CONSECUTIVE DAYS. ONLY ONE SALE IN A 12 MONTH PERIOD IS PERMITTED.
4. LICENSE MUST BE PROMINENTLY DISPLAYED ON PREMISES UPON WHICH SALE IS BEING CONDUCTED.
5. SALE MAY ONLY BE CONDUCTED BETWEEN THE HOURS OF 9:00 AM AND 6:00 PM., MONDAY THROUGH SATURDAY, AND BETWEEN THE HOURS OF 12 NOON AND 6:00 PM., SUNDAYS AND HOLIDAYS.
6. NO MORE THAN TWO (2) SIGNS, EACH OF WHICH MUST NOT BE LARGER THAN 24 X 12 INCHES IN SIZE, ARE PERMITTED. THESE SIGNS MAY ONLY BE POSTED ON THE PREMISES AND REMOVED WITHIN TWENTY-FOUR HOURS AFTER THE COMPLETION OF THE SALE.
7. LICENSEE WILL BE RESPONSIBLE FOR THE MAINTENANCE OF GOOD ORDER AND DECORUM DURING THE HOURS OF SALE, NO LOUD OR BOISTEROUS CONDUCT WILL BE PERMITTED NOR SHALL THE PASSAGE OF TRAFFIC ON THE ROADS BE IMPEDED
8. LICENSEE WILL BE FURTHER RESPONSIBLE TO COMPLY WITH THE REASONABLE ORDERS OF THE POLICE DEPARTMENT AND THE FIRE DEPARTMENT IN ORDER TO MAINTAIN PUBLIC HEALTH, SAFETY AND WELFARE.
